The rights assigned to Legal Atlas by me include all United States and foreign copyrights, all copyrights under any treaties, conventions, proclamations or the like, and all renewals, extensions or continuations thereof; all artistic and literary property rights; all moral rights; and all rights to apply for or obtain any registration certificates for copyright in Legal Atlas's or my own name.
